Upon contract approval, Sponsors must make their own hotel reservations if a Gold or Silver sponsor

- Due to limited space, NCNEOA will select exhibitors on a first come first served basis
- Deadline for Sponsorship registration is March 31, 2017
- Liability, Insurance and Hold Harmless: In consideration for the opportunity to display services and products at an NCNEOA conference, Exhibitor/Sponsor, it's officers, directors, agents and insurers agrees to indemnify and hold harmless NCNEOA, it's officers, directors, members, contractors and agents of the Hotel, it's government entity, agents and employees from any loss, injury, suit, action or cause of action, or claim whatsoever resulting from any incident, accident, fire, theft or any claim or loss to any person claiming loss or injury, including any loss or damage to property of Exhibitor/Sponsor, it's employees, agent or subcontractors, loss or injury to any manufacturer's demonstration participants, their employees, agents, guests and general public. Said indemnification and agreement to hold harmless NCNEOA and the Hotel as aforesaid, shall include reimbursement for any costs, expenses and reasonable attorney fees incurred by indemnities. Further, any claim of damage to the property of the conference center resulting in the immediate assessment of damages against NCNEOA from any act or omission of Exhibitor/Sponsor its employees, contractors and subcontractors shall be immediately paid or assumed by Exhibitor/Sponsor.
